WHEREAS The Council of the Municipality of Markstay-Warren has received a request for the gifting of Lands Municipally owned known as 51 Jean Street in the Municipality of Markstay-Warren (Roll# 520800000403700) by HFHOGN;

WHEREAS The Council of the Municipality of Markstay-Warren has received a request for the gifting of a portion of the Lands Municipally owned knows as 17 Warren Avenue in the Municipality of Markstay-Warren as surplus;

AND WHEREAS the Council of the Municipality of Markstay-Warren declared the lands located at 7 Hagar St Markstay-Warren Municipality as surplus;

AND WHEREAS the Council of the Municipality of Markstay-Warren declared the land at 51 Jean St Markstay-Warren Municipality as surplus;

AND WHEREAS the Council of the Municipality of Markstay-Warren declared a portion of the lands at 17 Warren Avenue Markstay-Warren Municipality as surplus;

NOW THEREFORE the Council of the Corporation of the Municipality of Markstay-Warren enacts as follows:

THAT Council endorses and approves the Gifting of Lands as requested, subject to the condition of HFHOGN Board of Directors approval for the organization to acquire the named properties above, and subject to the condition that HFHOGN shall reconvey the lands to the Municipality should it not diligently proceed with the construction of affordable housing and with each party being responsible for their own legal cost and disbursements.

THAT the CAO/Clerk of the Municipality of Markstay-Warren is hereby authorized and directed to do all things necessary to give effect to the said action or to obtain approvals where required, except where otherwise provided:

THAT the CAO/Clerk provide HFHOGN with the site survey, verification of environmental clearance/completion, confirmation of rezoning as required, and verification of service connectivity at the property lot line.

THAT the Property is also free of development fees, permit and administration fees, and property tax concession during the build. All conditions are subject to final Habitat Board approval.

AND THAT the CAO/Clerk and the Mayor are hereby authorized and directed to execute all

necessary documents to affect the transfer and to implement the condition set out in paragraph 1 (through registration of an Option to Purchase) and to affix the Corporate Seal of the Municipality of such documents.
